

#### **Terms and conditions:**

1. The upper age limit for Research Assistants is 30 years on the date of interview.
2. Candidate should submit their bio-data in person while attending the interview from 9.30 Am to 10.30 AM. The registration process will be closed by the above specified time on the date of Walk-in-Interview.

3. The position is purely temporary and co-terminus with the project. The engagement will be treated as consultancy service and does not guarantee subsequent employment.
4. Candidates should bring original testimonials on date of birth, educational qualification and experience certificate, if any for verification. Attested copies of the same are to be attached with bio-data form while appearing for the interview. Candidate without provisional certificates / degree certificates awarded by the universities will not be permitted to attend the interview.
5. If at any time, in the opinion of the APCCF (Research & Utilization), Bangalore are found neglected or unable to carryout research or guilty of conduct unbecoming of Research Assistants, the APCCF (Research & Utilization), Bangalore shall have the power to terminate the position at any time without notice.
6. The position can also be terminated at any time by the APCCF (Research & Utilization), Bangalore without assigning any reason or earlier depending on the performance of the candidates.
7. The APCCF (Research & Utilization), Bangalore will be empowered to engage them in any research work in any silvicultural zones as and when required.
8. The Research Assistant will carry out work under the general guidance of the CCF (Research) or CF (Research) of respective zonal offices. The APCCF (Research & Utilization), Bangalore will be overall controlling and monitoring officer.
9. The Research Assistant will submit monthly report of research works done through proper channel to the APCCF (Research & Utilization), Bangalore. He / She will also hand over all the notes, records etc., to the officer authorized by the APCCF (Research & Utilization), Bangalore after the completion of the project or in case of him / her termination / resignation.
10. Once a Research Assistant accepts the position and joins, it is obligatory for him / her to continue the work for the fixed period.
11. Canvassing in any form will disqualify the candidate.
