That the Forest Guard shall undergo the training and persue his studies with all due diligence during the course of his training in the aforesaid Institution.

That on completion of the studies the Forest Guard shall return to the Karnataka State and serve the Department for a period of not less than five years or in the alternative refund the cost of the entire training expenses for the period of Training with 8% interest and further such amount may be recovered from the Forest Guard and sureties jointly and severally as arrears of land revenue which the Government may levy thereon.

That in case the Forest Guard fails, except for sufficient causes, to fulfill any of the above conditions or is removed from the Forest Guard Training Course at the aforesaid Institution, the authorities concerned on any ground inclusive of misconduct or unsatisfactory progress in the Institute, or drops out of his own accord the Forest Guard and the Sureties shall jointly and severally agreed to pay the full amount of expenses incurred on this account with such interest as the Government may in their opinion fix and demand and further that such amount may be recovered from them either individually or jointly as arrears of land revenue. In the event of the Forest Guard fails in any examination and if he is to repeat the course with the permission of the State Government, the Forest Guard shall do so provided the entire cost of such repetition is borne by the Forest Guard himself/herself.

That it is distinctly understood and it is hereby expressly agreed that any illness or incapacity occasioned by the Forest Guard own or carelessness shall not be considered as sufficient cause for non-fulfillment of any of the aforesaid conditions.

That the Forest Guard and the Sureties hereby agree to accept the decisions of the Government as to what is sufficient cause to be conclusive and binding on them.
